# A Review of the MCHA Pet Policy

- Pets must be maintained within the resident's unit. When outside of the unit (within the building or on the grounds) dogs and cats must be kept on a leash or carried. They must be under the control of the resident or other responsible individual at all times.
- Pets owners are not allowed to permit pets to deposit waste on MCHA property. In the event this happens, pet owners are required to immediately clean up the waste.
- The pet owner shall be responsible for the removal of waste from any public housing property by placing it in a sealed plastic bag and disposing of it properly.
- The pet owner shall take adequate precautions to eliminate any pet odors within or around the unit and to maintain the unit in a sanitary condition at all times.
